**REYC CLUBHOUSE AND RIVER DOCKAGE**



Located on the scenic Grand River in Lake County's Village of Fairport Harbor, River's Edge Yacht Club is one of the newer clubs on the river. River's Edge combines a relaxed atmosphere with the boating lifestyle experience within a family-oriented environment. We have several social and cruising events as well as children's activities while offering a very affordable cost of membership. It is a place where guest and friends are welcomed for a simple barbecue at your dockside or at any one of several club sponsored social functions held throughout the year.

Established in June of 1997 from amongst dockers at the Riverbend Marina, the initial 19 members purchased bonds to finance the construction of the clubhouse facility which was completed in 1999. All construction bonds are now retired and the Club membership has grown steadily approaching 100 members.

Located at approximately 41°44.14N/081°16.28W on the Grand River within the Riverbend Marina, we are I-LYA and GCBA affiliated and offer transient dockage with power and water, and an air-conditioned clubhouse facility.

The 2250 ft<sup>2</sup> Clubhouse includes restrooms, showers, ice, washer and dryer, TV, music system, a fully equipped kitchen, and beverage center. A children's playground and a large barbecue/fire pit are immediately adjacent to the Clubhouse. Several restaurants, convenience and food/beverage stores, beaches, museums, fuel docks, and boat ramps are located close by. A boat lift, pump out, and other marine services are available on-site through Riverbend Marina.

Perhaps unique to REYC, the family membership plan treats both spouses equally whereby each spouse holds full voting privileges in the decision making process affecting Club operations and its governance. There are no "work hour" requirements; staffing for social functions and club maintenance are performed by its membership on a voluntary basis. Additionally, the Clubhouse is available to the member for private parties for a reasonable fee.
